MCHA to Offer Low-Cost, Appointment-Free Vaccine Clinic for Dogs and Cats on Sunday, June 8

Bloomington, IN – Monroe County Humane Association (MCHA) is excited to announce its June event to help local cat and dog owners keep their animals safe and healthy.

On Sunday, June 8, 2025, the Perry–Clear Creek Fire Department will host MCHA’s walk-in mobile vaccine clinic at Monroe Fire Station 21 located at 9094 S. Strain Ridge Rd, Bloomington, IN 47401. MCHA’s dedicated veterinary team of volunteers and staff will be available from 1–3 p.m. with no appointment needed; all are welcome!

Mobile Clinics offer a range of services, including legally mandated rabies vaccines for pets aged 12 weeks (about 3 months) and older. Additionally, clinics provide nail trims, anal gland expressions, microchips, and preventive measures for flea, tick, and heartworm.

Protect Your Dog and Save Money at the June Mobile Vaccine Clinic:

Leptospirosis is a serious, life-threatening disease that can spread to humans, so keeping your dog protected is essential. When you choose to vaccinate your dog against Leptospirosis at our June Mobile Vaccine Clinic, you’ll receive a FREE Distemper/Parvo (DAPP) vaccine—a savings of \$18–\$22! Take advantage of this special offer and safeguard your pet’s health while saving money!

Subsidized rates are available to residents experiencing financial hardship. To qualify for these rates, residents should bring valid documentation with them to the Mobile Vaccine Clinic. Safety is paramount. Cats must be in carriers, and dogs must be leashed (no retractable leashes). It’s essential for pet owners to understand that pets showing signs of illness or aggression might be turned away.

VACCINATIONS

Rabies vaccine: \$25 (\$15)

3-year Rabies vaccine (must show proof of previous vaccine certificate): \$30 (\$20)

Canine DAPP vaccine: \$22 (\$18)

Canine Bordetella vaccine: \$22 (\$18)

Canine Leptospirosis vaccine: \$35 (\$25)

Feline FVRCP vaccine: \$22 (\$18)

Feline Leukemia vaccine: \$35 (\$25)

WELLNESS SERVICES

Microchip: \$18 (\$15)

Nail trim: \$18 (\$12)

Nail trim, aggressive animal: \$25 (\$15)

Anal gland expression: \$18 (\$15)

Heartworm Exam and Test: \$45 (\$15)

HEARTWORM PREVENTION

A heartworm test/exam is required to purchase prevention.

Interceptor (Chew), One Dose: \$13.50 (\$10)—Heartworm, Hook & Roundworm

Advantage Multi (Topical), One Dose: \$22.50 (\$18)—Heartworm, Flea, Hook & Roundworm

Simparica Trio (Chew), One Dose: \$41.00 (\$31)—Heartworm, Flea, Tick, Hook & Roundworm

FLEA/TICK PREVENTION

Provecta Advanced, Dogs, One Dose: \$15.00 (\$11.50) (+Tax)

ParaMonthly, Cats, One Dose: \$10.00 (\$8.00) (+Tax)
